# CALIFORNIA

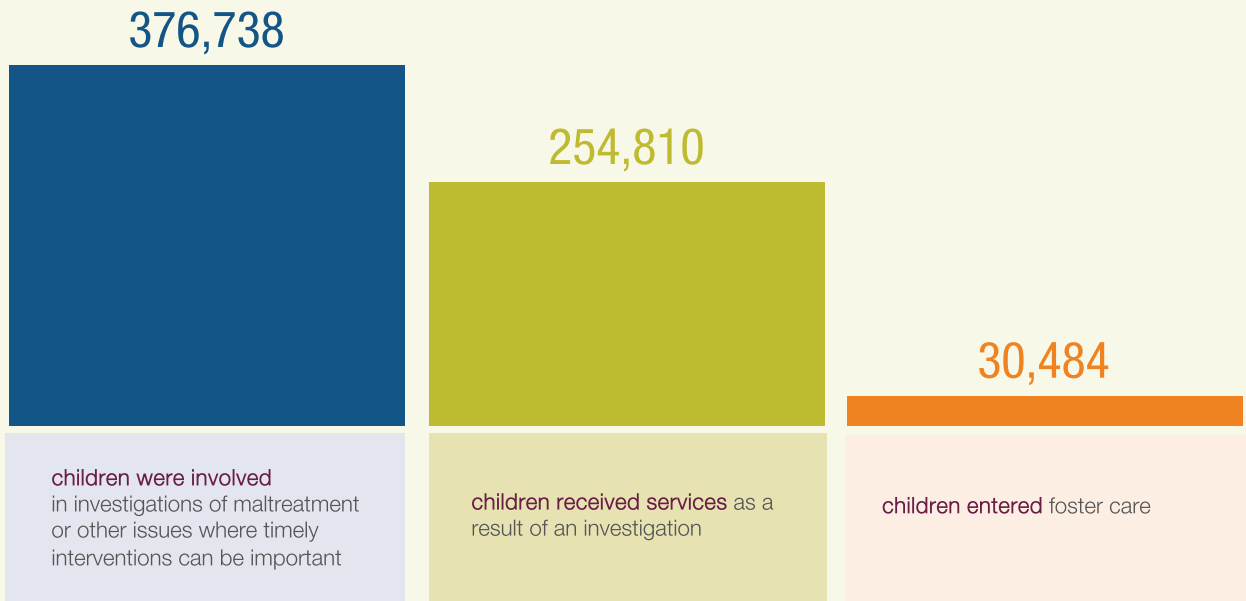
Casey Family Programs works in all 50 states, the District of Columbia and two territories and with more than a dozen tribal nations to safely reduce the need for foster care and build Communities of Hope for children and families. From 2008 through 2018, Casey Family Programs will have invested **\$114.6 million** in California to support the work of the child welfare system, courts, policymakers and organizations that support children and families.

Approximately 3.5 million children across the country were involved in an investigation or alternative response for maltreatment in 2016. About 422,000 children under the age of 18 currently live in foster care. To truly transform the child welfare system in America, we should make more effective investments at the federal, state and local level to support programs that keep children safe from harm, safely reduce the need for foster care and produce better outcomes for children and their families.



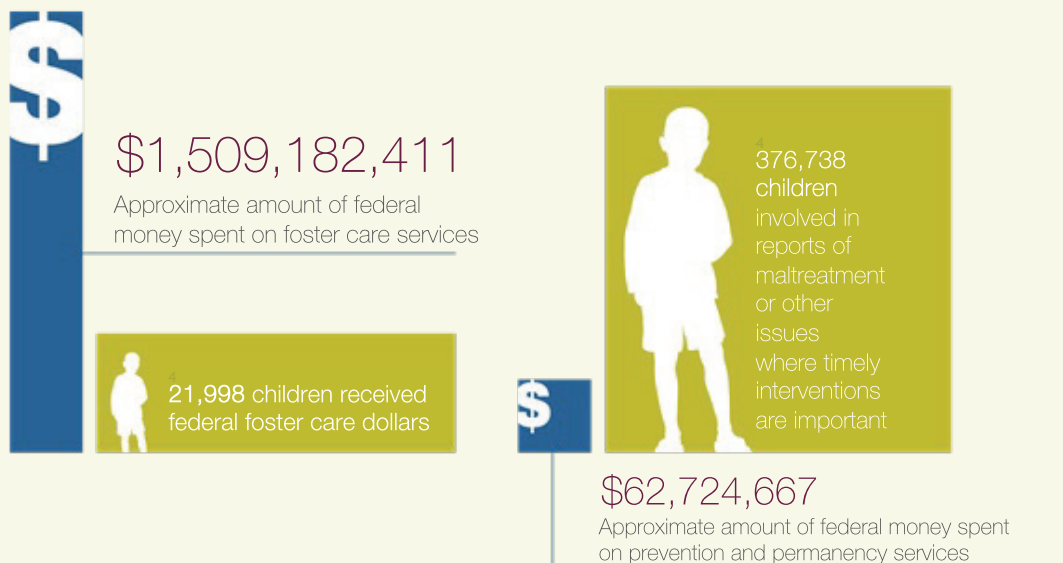
We talk about a “foster care system,” but the goal is to prevent abuse and neglect and help every child grow up safely in his or her own family whenever possible. Rather than waiting for maltreatment to occur, we can improve the safety of children who have come to the attention of child protective services by helping their families with evidence-based and promising practices.

Across California in 2016, approximately:



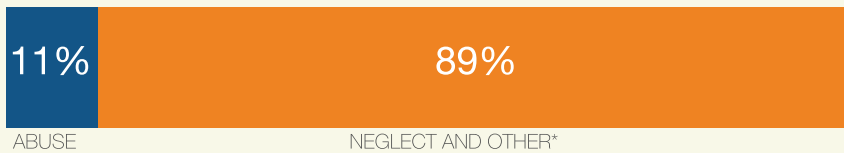
Most states currently use the bulk of the \$7.3 billion in dedicated federal child welfare funding only for services related to foster care. The Family First Prevention Services Act of 2018 provides states with the historic opportunity to invest federal funding to support up-front services including substance abuse, mental health and parental skills training. States can now begin to rebalance their investments and shift their focus from foster care services for some children to prevention and permanency services for all children.

How federal child welfare funding is currently aligned in California:



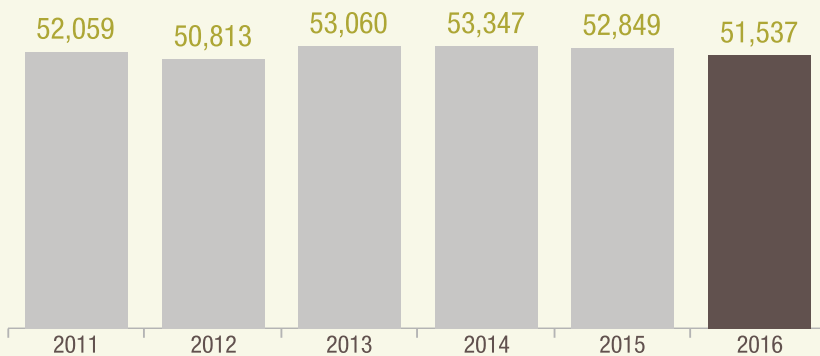
Safety and effective response go hand in hand. Most children enter foster care due to neglect and other reasons — not because of physical or sexual abuse. In California, providing targeted and effective interventions as soon as possible can safely prevent the need for foster care and better ensure that children who suffer any kind of maltreatment are not harmed again.

Reasons children in California enter foster care:



95% of children in California do not experience a repeat occurrence of maltreatment within six months

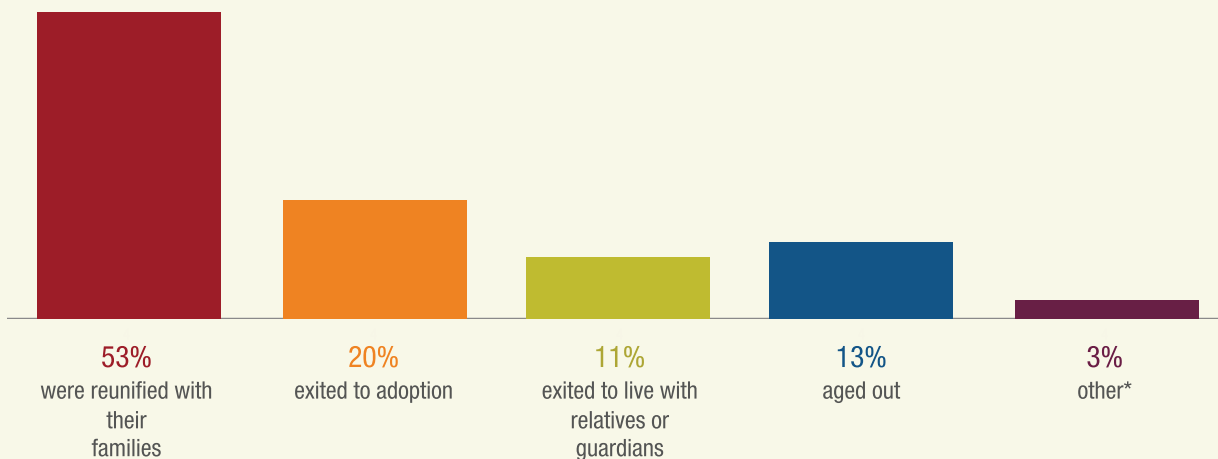
Children under age 18 living in foster care in California:

What happens to children who end up in foster care? Most are safely reunited with their own parent or extended family. A significant number are adopted. Communities across America have shown that they can help more children to grow up in safe, stable families by providing appropriate and timely services prior to the need for removal, or after they return home or have been adopted.

# Progress in California and new opportunity

California has received a waiver to invest federal dollars in innovative ways to reduce child abuse and neglect. These federal demonstration projects, which are scheduled to expire in 2019, have allowed states to use funds previously allocated to foster care to implement innovative and evidence-based strategies so children can grow up happy, healthy and strong.

California's Continuum of Care Reform initiative (CCR) grew out of 2011 legislation and charts a path toward individualized child and family centered care, building on previous efforts to reduce maltreatment, increase permanency, reduce congregate care, and lower re-entry to care. Together with the efforts of the waiver, California continues to leverage existing policy and financing opportunities to develop services customized to meet the needs of Californians to support youth and families interacting with the system at-large at different points in time to prevent maltreatment, promote well-being and ensure safety, provide trauma-informed family-based care, and increase the availability and use of home-based settings.

To succeed, California is relying on the following intervention models:

- Safety Organized Practice
- Facilitated high-quality Child and Family Team models
- Integrated Core Practice Model
- Statewide clinical/functional assessments
- Wraparound services
- Trauma-informed systems and services
- Parent education and mentoring
- Data transparency and quality improvement

The newly enacted Family First Prevention Services Act of 2018 reforms how federal child welfare is financed to enable states and tribes to target services to families who are at risk of entering the child welfare system. By allowing federal reimbursement for key services prior to maltreatment occurring, California has new opportunities to successfully achieve the vision of its current efforts to help vulnerable families heal, improve safety and develop into strong communities.
